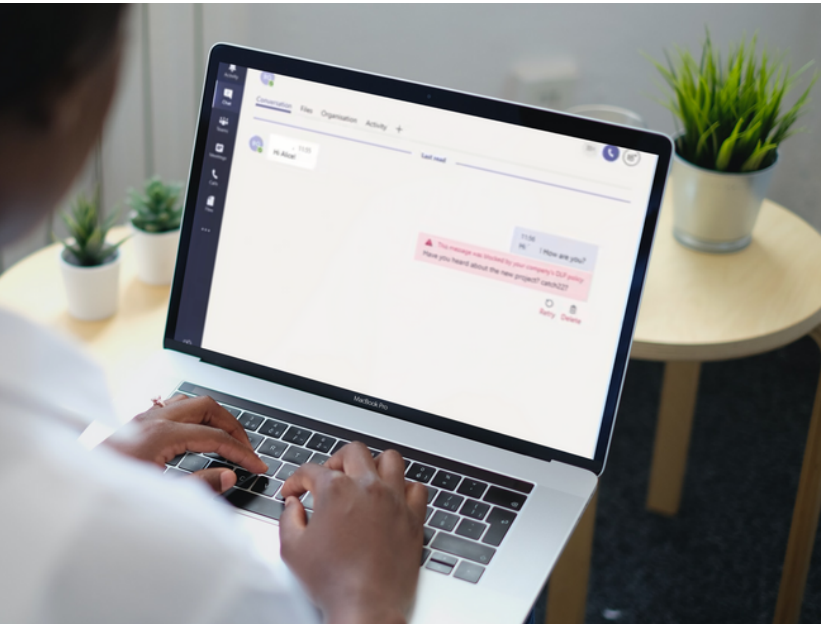

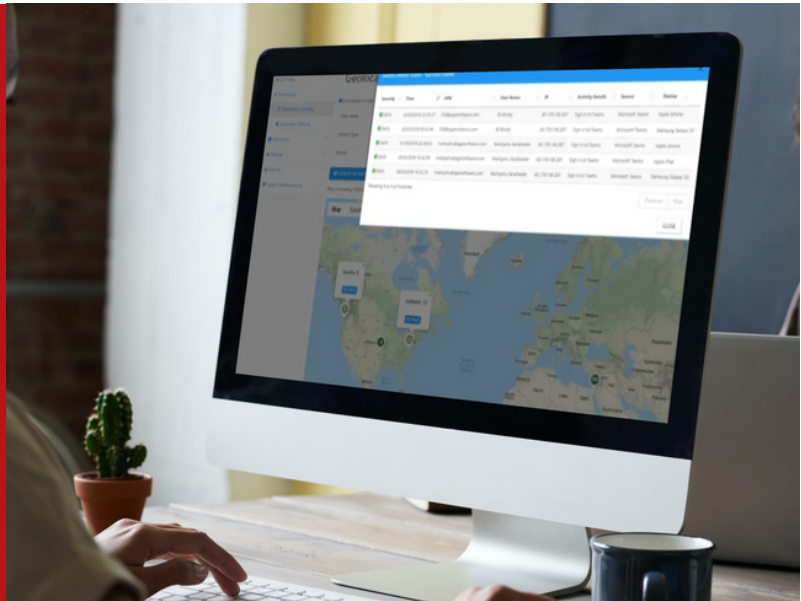
### **Features of Recording AI Compliance Analysis**
